- Your business has been nominated by completing and submitting the nomination form
- Your business is registered and/or operates (as the primary place of business) in at least one of the towns of the South Burnett Region
- Your business has a registered Australian Business Number
- You agree to submit a letter from your accountant stating that your business is in a financially viable position
- You will notify organisers of any potential conflict of interest with judging panel
- You agree to undergo the entire selection process including site visits and meetings if required
- You will notify organisers in your individual capacity or in your capacity as director, trustee or representative of the entity nominated and entering of any:
 - Judgements, writs from a court tribunal or other similar body in Australia (whether or not a conviction or judgement was recorded against the relevant entity)
 - Claims, applications or other proceedings which have commenced (regardless of whether it was prior to or after execution of this agreement) within Australia that may compromise the integrity of the South Burnett Business Excellence Awards
- If your business is deemed to better suit an alternative category, you agree to that change, upon consultation with the South Burnett Business Excellence Awards Committee
- You agree to your business being included in any promotion associated with the awards where necessary
- You agree that the judges reserve the right not to present an award if the circumstances do not warrant such an award
- If nominated for a People's Choice for Customer Service/Customer Relations Award you agree to participate in the Award's process including receiving a mystery shopper to your business and, if successful as a finalist, attend the award night function (you will receive 2 free tickets).
